# Ministry growing at unprecedented rate; memberships up 42 percent since 2010

Christian Healthcare Ministries is experiencing unprecedented growth: memberships have increased 42 percent since the beginning of 2010.

The percentage of Gold level members has grown from 40 to 51 percent during the same

period.



"God is blessing Christian Healthcare Ministries, and we're giving Him the glory," said CHM President Rev. Howard Russell. "We're honored that He is opening doors for us to serve more Christians every day to help them with their health care costs."

Russell added that increased awareness of the ministry—the result of many factors—has created opportunities to serve believers with a common faith but diverse backgrounds.

Without that trinity—*the*Trinity—this ministry could not work.

CHM's existence and growing influence can only be explained by the actions of the Father, Son and Holy Spirit.

Here's an excerpt from a letter that appeared in December's newsletter. Written by Julie Courson of Newberg, Ore., it's indicative of the spirit of CHM members:

"Thank you so much for all of the help, care, and financial support you recently extended to me and my family. My husband, Jim, and I are both very grateful to you. After my knee injury, my husband called and spoke with a very helpful CHM staff member. We had not yet needed help from the ministry, so the care and advice we received the first time really blessed us. We

## Prayer Page needs down 60 percent in 2012

Christian Healthcare Ministries members in 2012 demonstrated their faithfulness in meeting each another's needs by increasing their contributions to the Prayer Page, which helps members with certain medical bills for pre-existing conditions.

The dollar amount of unpaid Prayer Page bills decreased more than 60 percent from an all-time high in December 2011 (\$894,317) to \$350,689 in December 2012.

CHM Chief Financial Officer Roger Kittelson said there are likely several reasons for the dramatic decrease. "Though the number of people requesting help through the Prayer Page has remained fairly steady, giving has increased due to a higher awareness of these needs," he said. He explained that members were encouraged to give toward Prayer Page needs in lieu of quarterly giving through the CHM Brother's Keeper program—which had \$0 in financial gifts due for four straight quarters.

"A significant increase in new CHM memberships also positively affected Prayer

Page giving," he said. (See the related article on page 1.)

Though the numbers are encouraging, the fact remains that Prayer Page needs fluctuate and can increase as quickly or more quickly than other needs are met. People seeking help with medical bills from pre-existing conditions are added to the Prayer Page nearly every month—and those with needs already on the Prayer Page sometimes add more bills. "We consistently list 60 to 65 people on the Prayer Page at any given time," Kittelson said.

The Prayer Page is part of CHM's overall effort to help Christians with bills from pre-existing conditions. In general, such bills fall into three categories:

1. Bills incurred prior to joining CHM or bills incurred when, at the time members join, they are undergoing "active"

# Your fitness program: intentional or just good intentions? *By Judi Ulrey*

Are you taking good care of yourself? Are you exercising regularly and eating healthfully? Why is it that our personal health is often just a wish or a desire, but not an intention?

Intentional means that something is done on purpose or with determination; it's not accidental.

Is "intentional" how you would describe your fitness program? Healthy eating and

exercise don't accidentally happen.

Here are a few tips to be intentional about your fitness:

**1.Be clear.** Instead of saying, "I'm going to get in shape this year," or "I'm going to lose weight," be specific and clear: "I'm going to exercise Tuesday, Thursday and Saturday mornings for a minimum of 30 minutes." "I'm going to start every day with a healthy breakfast." "I'm going to move

# Making elderly, "cemented" brains flexible once again

The speed of a child's brain is simply amazing. An adult may study a foreign language for hours before speaking a few words, while a child can form foreign sentences after hearing a few recorded words. Wouldn't it be astonishing if adults' brains could somehow recapture the impressionability of children's minds? According to recent research, that is a future possibility.

Think of a baby's brain as soft limestone. As information flows in, it carves out patterns in the limestone, sculpting the growing brain with rivers and streams. Over time, essential connections between nerve cells enlarge and solidify into cemented patterns of "granite," while less-used connections disappear. The impressionable brain systems that enable a young child to master a new language with speed and strength harden with time.

In the 1960s, Nobel Prize recipients David Hubel and Torsten Wiesel conducted important research on the brain's flexibility ("plasticity"). They found that temporarily sealing shut a kitten's eye during the early stage of its life destroyed the cat's ability to see normally from that eye. However, when the opposite eye was patched, the underdeveloped eye completely

recovered normal vision—as long as the patch was used when the animal was young.

Interestingly, humans have this same stage of opportunity, called the "critical period," during which new connections are formed between nerve cells in the brain. For example, since *amblyopia* ("lazy eye") produces double vision, the brain automatically suppresses input from one of the eyes.

The ignored nerve connections



die off, and that eye becomes completely blind (the eye itself is capable of vision, but the related brain tracts essentially disappear). Placing a patch over a child's good eye causes the brain to rewire the weaker eye. In contrast, patching an adult's eye does nothing; the brain doesn't respond.

However, neuroscientists now believe that adult brains can recover at least some of the "soft limestone" of youth. Early research suggests that halting molecular stop signals or altering the flow of nerve cell activity can renew youthful flexibility. Reversing brain rigidity opens the door to amazing potential. Neuroscientists hope that recovery of a "soft" brain in adults may stop the decline in vision that occurs with old age, reverse the effects of stroke or possibly even repair a severed spinal cord.

Neuroscientists are working to discover what causes the critical period to end and what can

be done to bring back the impressionable brain system of youth. For example, research shows that one of the structures involved in cementing nerve cells into place, a *perineuronal net*, forms a tight mesh with texture resembling cartilage similar to your earlobes. Mice brains with abnormal or missing perineuronal nets can be, in effect, sculpted.

Myelin, the fatty sheath that envelopes nerve axons (fibers), may contain another such substance. Functioning like insulation around an electric wire, myelin speeds messages through nerves to the brain. Although speed is an advantage, neuroscientists determined that high speed produces less flexibility because the nerve cell fibers are held in place by myelin. Removing myelin from nerve cells in mice restores plasticity (although it

## Taxes and CHM

Your monthly financial gifts required for CHM membership are not deductible for federal income tax purposes.

However, extra giving above your minimum monthly gift amount—including Prayer Page gifts sent through the CHM office—are deductible. (Prayer Page gifts sent directly to other members are not tax-deductible).

## Special tax advantage for Missouri members

All CHM members who gave extra gifts in 2012 will receive a statement of charitable contributions in January 2013. The statement contains the total deductible amount if your giving fits IRS requirements for deductibility.

Missouri state law provides residents with a special tax advantage. The Missouri Form MO-1040 lists a "health care sharing ministry" line item deduction. When you file your taxes, write on this line the total amount you sent to Christian Healthcare Ministries in 2012 (indicated on the aforementioned statement).

treatment of their pre-existing conditions (such bills are ineligible for sharing through any CHM program)

- 2. For Gold level members: bills incurred for medical incidents after members have begun a maintenance treatment regimen (such bills can be shared through the regular CHM sharing program according to a predetermined schedule)
- 3. For Gold, Silver and Bronze members:

bills incurred for medical incidents after members have begun a maintenance treatment regimen (such bills are eligible for sharing through the Prayer Page)

"The Prayer Page is a powerful, effective and compassionate tool," said CHM President Rev. Howard Russell. "Members often express their gratitude not only for financial donations received through the Prayer Page, but for the encouragement and support they receive when other members reach out to them via letters or cards of encouragement."

My condition was pre-existing, so these bills did not qualify for CHM's regular cost-sharing program. However, the staff at CHM told me that I could have my need listed on the Prayer Page, which has been very encouraging.

I'm now waiting for a follow-up procedure to help with my condition, and I know that God will be faithful in providing for that as well.

I've really appreciated receiving gifts from other CHM members each month toward my bill. Many of them come with a personal note. The fact that my monthly gift goes to help fellow believers like the ones who have helped me with my bills is one of my favorite things about CHM.

accident in Feb. 2009, which caused very severe neck and arm pain. My doctors recommended cervical disc replacement surgery on my C4 and C5 vertebrae the following year.

In Dec. 2010, the neck and arm pain returned. I underwent several medical tests, which revealed that my body rejected the disc replacement and never completely healed. My doctors recommended cervical fusion surgery in May 2011.

Because my back problems began before I joined CHM, they were considered a pre-existing condition. for a minute at least three times per day." (Editor's note: For examples of one-minute moves you can do at your work desk, see Iudi's article in the CHM November 2012 newsletter, available at www.chministries. org/newsletter.aspx.)

Action step: Journal your intentions and

share them with a friend.

**2. Be reasonable.** Many people become overly zealous in the beginning of their fitness programs. We start out too hard, work out for too long or say we're going to commit to a daily routine that isn't realistic. Remember the tortoise: slow and steady wins the race. Make small first steps and expand from there.

Action step: Review your intention inventory. Are your plans reasonable and sustainable?

As long as you keep track, share your log with someone. The power of accountability is amazing.

**4. Pay it forward.** One of the best ways

to strengthen your resolve is to encourage another person. How can you encourage someone else to eat a healthy breakfast if you leave home each day without fueling your body? The more you support and encourage others in their wellness journey, the more you'll stay committed.

Action step: Who in your life could use some encouragement and support in their fitness program? Is there someone to whom you can pay it forward?

**5. Celebrate success.** Pat yourself on the back for a job well done. You were intentional about it. You did it. Celebrate it!
