Throughout the United States, hundreds of thousands of Christians use biblical principles to meet healthcare costs. How? Through Christian Healthcare Ministries (CHM).

CHM's mission is to glorify God, show Christian love and experience God's presence through the sharing of each other's medical bills. We do this by following the command of Galatians 6:2: "Carry each other's burdens, and in this way you will fulfill the law of Christ." This is the cornerstone of who we are and why this ministry exists.

CHM members—regular people like you and me—join and follow the New Testament example in Acts 2 and 4. CHM combines the commitment of its members with a biblically-based mechanism that works. This past year, CHM members shared almost \$500 million of each other's expenses—enabling the ministry to reach a milestone of sharing \$5 billion since the ministry's inception in 1981. Simply put, it's God's biblical design and favor that empowers CHM members to share one another's medical bills.

Craig Brown | **President and CEO**



Craig Brown is the President and Chief Executive Officer of Christian Healthcare Ministries (CHM).

Craig graduated from the University of Cincinnati (Ohio) with a bachelor of business administration. While there, he volunteered for two years at the Christ Hospital in Cincinnati in a variety of roles. He later went on to earn his master of business administration from Ohio Christian University (Circleville, Ohio).

After graduation, Craig began working as an accountant at Faxon Machining, a fast-growing, single-source manufacturing company serving the automobile, defense, aerospace, and oil and gas industries. He rose to the position of Chief Financial Officer. Subsequently, he formed and operated a burgeoning real estate and restaurant-holding company for more than a decade.

Prior to his role at CHM, Craig served in several different roles at Ohio Christian University (OCU). These roles included Special Assistant to the President, Vice President for Advancement and Vice President for Entrepreneurship. His final role at OCU was Chief Relationship Officer. In addition to serving as OCU's corporate and legislative liaison, he led numerous internal and external initiatives collaborating with a wide spectrum of church and parachurch organizations. He also provided leadership from concept to completion for OCU's Ministry and Performing Arts Center and the Robert W. Plaster Free Enterprise Center, which was a public-private collaborative economic development project.

Charity Beall, CPA | **CFO and Treasurer**



Charity Beall is the Chief Financial Officer and Treasurer of Christian Healthcare Ministries (CHM).

Charity graduated from The Ohio State University (Columbus) with a double major in finance and accounting.

After graduation she pursued a career in public accounting, specializing in auditing not-for-profit organizations. She became a Certified Public Accountant and obtained her Toastmasters Competent Communicator certificate. Charity has presented at events focused on encouraging women, including Real Women, Real Careers and multiple events sponsored by the American Society of Women Accountants (ASWA).

Charity learned about CHM when the firm for which she was working appointed her as senior accountant on CHM's 2003 independent outside audit. In 2008, she became CHM's Director of Finance. 



CHM PARTICIPATION

The qualifications for joining are simple: Participating adults must be Christians who attend worship regularly as their health permits (Hebrews 10:25), actively follow the teachings of the New Testament in its entirety and embrace the CHM Statements of Beliefs.

There are no membership restrictions based on age, weight, geographic location or health history.

CHM members follow biblical principles with respect to the use of alcohol and abstain from practices inconsistent with a biblical lifestyle, including (but not limited to) illegal drugs, tobacco, nicotine, any smoking device and sexual immorality as defined in the Scriptures and expressed in CHM's Statements of Beliefs.



GOLD | \$172 PER UNIT, PER MONTH

CHM shares 100 percent of bills in most cases (up to \$125,000* per illness) for any medical incident exceeding \$500 when all other Guidelines are met, including: inpatient or outpatient hospital incidents and surgery; medical testing; maternity; physical therapy and home healthcare (up to 45 visits); incident-related doctor's office visits; incident-related prescriptions. (See chministries.org/guidelines for more information.)

SILVER | \$118 PER UNIT, PER MONTH

Members have a \$2,500 Personal Responsibility per incident; CHM shares the bills (up to \$125,000* per illness) for inpatient or outpatient hospital incidents and surgery performed at any certified surgery center. Testing and treatment outside a hospital do not qualify for sharing. Maternity is ineligible for sharing on the Silver level. (See chministries.org/guidelines for more information.)

BRONZE | \$78 PER UNIT, PER MONTH

Members have a \$5,000 Personal Responsibility per incident; CHM shares the bills (up to \$125,000* per illness) for inpatient or outpatient hospital incidents and surgery performed at any certified surgery center. Testing and treatment outside a hospital do not qualify for sharing. Maternity is ineligible for sharing on the Bronze level. (See chministries.org/guidelines for more information.)

***BROTHER'S KEEPER | \$40 ANNUAL FEE + \$45/UNIT QUARTERLY AVERAGE**

Brother's Keeper is an additional program for medical bills exceeding \$125,000 per illness. For example, Brother's Keeper provides Gold members unlimited cost support per illness. (See chministries.org/guidelines for more information.)

CHM SHARING PROCESS

Member records: Medical bills and forms are received by mail, fax or through the online Member Portal and processed by CHM employees according to the date received.

Data entry: With few exceptions, almost all medical bills display information in different ways and places. Therefore, each bill's data must be keyed by hand into the CHM medical bill processing database. In addition, CHM employees verify that there are no duplicate charges (a common occurrence) or other billing mistakes made by members' healthcare providers.

Authorization: Staff members categorize bills into the appropriate illnesses and incidents (see the online glossary at chministries.org/glossary) and authorize bills according to the CHM Guidelines (chministries.org/guidelines).

Member advocacy: Employees review members'

bills to make sure the maximum discount has been obtained, and often verify discounts with members' healthcare providers.


Member reimbursement: Staff members perform a final bill audit, after which funds from the audited CHM bank account are released for sharing. The check is sent to the member via mail.*

Members receive their check(s) in the mail and pay their medical provider(s). At the end of 2019, sharing time was 120 days (more information on page 13). *(Note: At this report's publication in mid-2020, sharing time has been reduced to under 75 days.)*

How medical needs were met from 2015 – 2019




MEMBERS GO THE EXTRA MILE

The Prayer Page is an additional means by which CHM members help fellow members. Prayer Page medical needs appearing in *Heartfelt Magazine*, CHM's monthly publication, are ongoing bills incurred from pre-existing conditions, which do not qualify for sharing through the regular CHM programs (Gold, Silver, and Bronze). CHM members voluntarily donate funds above their regular CHM

monthly financial gift: 100 percent of this extra giving goes to help members in need. Members listed on the Prayer Page receive donations proportionate to their needs each month until their bills are shared in full.

The chart below represents the amount of voluntary donations shared monthly in 2019 to Prayer Page participants to pay their medical bills.

Q & A with Chief Financial Officer Charity Beall

Why did CHM have reduced revenue in 2019? For the past five years, CHM has experienced explosive growth, with over 310,000 new members sharing each other's burdens. As membership grew, so did our need for staff. Although we've

continued to implement numerous efficiencies, enabling fewer staff to serve more members, during the summer of 2019 we saw sharing time—time between receipt of medical bills and issuance of sharing checks—reach a peak of over 150 days. This occurred for several reasons, including an increase in medical bill submissions earlier in the membership timeline than had historically been the case. Praying for wisdom, and making additional process improvements, we worked diligently to reduce sharing time to 120 days by the end of 2019. This rapid reduction resulted in record-breaking amounts shared throughout much of 2019. To God be the glory!

From my chair as CHM's CFO, I'm often amazed by enormous medical costs and the need for God's healing touch for our members. As I pray for our members, the Holy Spirit reminds me that we serve a big God: He used CHM members to satisfy more than \$1 billion in medical expenses in 2019 alone. Praise be to our God, whose generosity is great and love for His children is even greater.

Why did CHM raise member gift amounts? CHM has a long-standing history of making decisions focused on glorifying God and serving members. Colossians 2:3 states, "In him (Christ) lie hidden all the treasures of wisdom and knowledge." We rely on Christ every day as we serve members' medical bills. One of CHM's 2020 goals is to reduce and maintain sharing time at 75 days or less (a goal that was achieved by this report's publication date in mid-2020). CHM leadership carefully observes and analyzes trends so we can respond appropriately and sustain this ministry that we serve on behalf of God's people. Trends we noted in 2019 were an increase in medical bill submission and a decrease in the rate of membership

growth. These two factors created the need for a membership gift increase. CHM maintained the same membership gift amounts for 12 years, and after detailed analysis, it was clear that a gift amount set in 2007, particularly in the current environment of rising healthcare costs, would not enable CHM to continue offering the same advantages. The decision to change gift amounts was a comprehensive process that involved significant reporting, analysis and review by the Leadership Team and the Board. Care for our members led us to give ample notice of the gift increase, which did not take effect until April 1, 2020. The most relevant part of the process was prayer. Though these decisions are difficult, the goal is to ensure the ministry's long-term ability to meet the medical needs of its members.

How does CHM combat rising healthcare costs? It's beneficial to all members to negotiate discounts with your providers and to ask for better pricing on your medical bills. Your faithful stewardship has produced a consistent increase in discounts of over five percent, across the board. CHM's entire reason for being is to glorify God first and foremost. We walk this mission, asking in faith with earnest expectation for God's protection, wisdom and favor. As His promises express, "My help comes from the Lord, who made heaven and earth!" and "The Lord keeps watch over you as you come and go, both now and forever" (Psalms 121: 2 and 8). We recognize God's faithfulness and your faithfulness as the root of the success and sustainability of this ministry. We are honored to serve you.

Since CHM isn't insurance, I had some reservations. I was nervous that the ministry was too good to be true and that we'd have to pay large bills in the event of a major medical expense. Little did we know that God would use three incidents—in rapid succession—to confirm that placing our faith in His people to meet our healthcare costs was just what we needed to do.

At the hospital we learned my wife's heart attack was caused by a bleeding ulcer that in turn had caused a dangerously low hemoglobin count. She was quickly transferred to a larger hospital in Atlanta, where she was stabilized in the cardiac intensive care unit and was treated for 10 days. To my surprise, the hospital reduced our bill from \$78,000 to about \$23,000—a discount of about 70 percent. I was equally astonished when a check for \$15,000 arrived from CHM about six weeks later. Meanwhile, I learned that Joan's expenses exceeding \$15,000 would be included on the Prayer Page, which is another program for pre-existing conditions. In this way, members would be able to send voluntary donations above and beyond their regular financial gifts to help us pay the rest of Joan's medical bills.


